Directors duties are owed to the company therefore in the main enforceable only by the company itself, although if the company's solvency is in doubt or it is insolvent, the directors also owe duties to the company's creditors by virtue of s172 (3) and this can be enforced by the liquidator or administrator.

Duties of Directors in Company Law

It covers the duty of care, the duty to act within powers, the duty to exercise independent judgement, and, most importantly, the application of fiduciary duties to various types of conflict of interest.

Abstract The general duties owed by directors to their companies are a critical element of company law overall, and corporate governance in particular. If these duties are breached, the board, acting on behalf of the company, is empowered to decide whether to take action against the miscreant directors.

The directors' duties are owed to the company itself, which may be equated to the collective interests of the shareholders. The fiduciary duties are not owed to other companies with which the company is associated, to other directors, or to any individual shareholder.
